Course Record Importer Instructions

The course record importer allows you to import participants into a course that is not using the ICEP learning portal for enrollment/registration.

To obtain a current template, go to <your activity> > enrollments > import > Download a template.

Below each Field Name is a column in the template. Remove any columns that are not required. If you see any reference to "global course importer" please ignore. We ONLY import at the course level, never at a global level.

Columns in the CSV correspond to rows in the grid below. **Use only columns in the CSV that are highlighted below.** If you desire to use a column that is not highlighted, discuss with Julie Martinelli first.

- Green = REQUIRED by ICEP
- Orange = REQUIRED only if we are providing credits and credit types for the learner. This is NOT the preferred method. The preferred method is that the import enrolls the learner in the course, and the learner is then directed to log in and complete any items such as evaluations, as well as claim credit.

If you are providing credits/credit types for the learner:

- If the learner IS eligible for the healthcare ce credit that is being offered, award him/her this credit ONLY. DO NOT also award him/her CEUs
- If the learner IS NOT eligible for the healthcare ce credit that is being offered, award him/her UW CEUs
- All records can be uploaded at one time using one spreadsheet CSV. For example, if a learner is eligible
 for two healthcare credit types that are being offered, create two rows for that learner, changing out
 only the credits and credit type information.

Additional Notes in *italics* are ICEP-specific.

credit_type	No	alphanumeric	The type of credits. Must use the values defined for each EthosCE implementation. If you don't know what these are, please check before importing. These values are located at <your activity="">> enrollments > import > Valid credit types. Must be written exactly as is. (For example, "ama," not</your>
credit_expiration	No	ISO 8601	"AMA") The expiration date of the credit record.

complete	No	boolean	1 if the course was completed by the user associated with the credit record. 0 if the course was not completed by the user associated with the credit record. Is only needed if ICEP is entering "credits" and "credit_type." Otherwise this will be marked complete once they finish any objects, including claiming credit.
date_completed	No	<u>ISO 8601</u>	The date the credit was awarded. If a date is not present and the import record has a 1 in the "complete" column, then the date of the user's next login will be used for completion date. Make the date_completed date the same as the last day of the activity. Is only needed if ICEP is entering "credits" and "credit_type." Otherwise this will be the date they finish any objects, including claiming credit.
attended	No	boolean	1 if the user attended. 0 if the user did not attend.
city	No	alphanumeric	255 characters maximum.
